- a quarterly cash dividend of \$0.4375 per share for the calendar quarter ending on September 30, 2016, on Birchcliff's outstanding Cumulative Redeemable Preferred Shares, Series C. The dividend is payable on September 30, 2016 to shareholders of record as at the close of business on September 15, 2016. The dividend is designated as an eligible dividend for purposes of the *Income Tax Act* (Canada).
